



1. The Great American Beer Festival (GABF) ticket giveaway (the "Competition") is open to residents of the United States and Canada aged 21 and over.
2. The Competition is not open to employees of Ardagh Group ("Ardagh"), their group companies or family members or anyone else connected to the Competition.
3. Entry into the Competition will be deemed as acceptance of these Terms and Conditions.
